Your questions answered

Q Can any BHF Group member apply?

A Yes, all BHF Group members can apply.

Q How are repayments made?

A All repayments must be made by standing order and should not be less than £20 per month.

Q What about loan insurance?

A Payment protection insurance is to be arranged at your own discretion. we do not offer this service.

Q What about VAT?

A For all items regardless of whether VAT is recoverable, the legal requirement is for the invoice to be made out to 'BHF Finance'. Typically if VAT is recoverable then this can be done on the authority of the finance document which will be your input advice. VAT on hire purchase agreements is recoverable on the next VAT return. VAT on leases is charged and recoverable on monthly installments, where we provide the invoice.

Q What about leasing?
